The meeting started with an Invocation song by Prof. Sheshaprasad, Associate Professor, BNMIT. The Chairman Sri. Narayan Rao R. Maanay welcomed all the members and briefly introduced all the members to the Governing Body(GB).

Later, the Chairman requested the members to deliberate on the subjects listed in the agenda.

1. Regulations for Autonomy at BNMIT

The Chairman Sri. Narayan Rao R. Maanay requested Additional Director Dr. S. Y. Kulkarni to present the summary of the Regulations for Autonomy at BNMIT. Dr. Kulkarni presented the details of Regulations to the committee members. Dr. Nagabhushan suggested to adopt formative assessments of students rather than summative assessments to reduce fear and increase learning ability. He also suggested to check the possibility of renaming the examination cell as Assessment Cell.

Resolution: The committee unanimously accepted Regulations for Autonomy at BNMIT with minor modifications as suggested by Dr. P. Nagabhushan.

2. Approval of various committees

The Chairman Sri. Narayan Rao R. Maanay requested Principal, Dr. Krishnamurthy G.N to present the various committees to the Governing Body for approval. Principal presented various committees along with the members to be nominated by the GB and requested the members to approve the committees and give their suggestions. Dr. Nagabhushan suggested to add at least one member from Institutes of National importance like IISc, NIT, IIT, IIIT and IIMs especially in Board of Studies of different departments if already not included in the list. He also suggested to check whether Sri. Narayan Rao R. Maanay can be made Co-Chairman of Finance Committee rather than a Member. The members also suggested to add external members to Academic Audit Committee.
