- 2. To motivate, train and support faculty for conducting cutting edge research
- 3. To engage in research activities that are for the benefit of society.

These driving forces are expected to allow us to achieve the following targets.

- To be one amongst the top Institutions in the country interms of research output and industrial / on field applications
- > To get the research findings published in high impact factor journals. It will work for raising the h-index of the Institution.
- ➤ To establish atleast 3 COEs in identified key area of research with emphasis on inter-disciplinary research.
- ➤ To get good ranking in NIRF and Accreditation by NBA and NAAC with good ratings.

- To endevour the generation of reasonably good income (3 to 3.5 L per year per program) from consultancy services.
- > To work towards increasing the grant from research funding agencies through quality project proposals by 15-20% annually.

In view of this focused effort to cultivate research culture in the Institution, a Research policy has been published on our website. This research policy has the scope for research, research funding, collaboration for research, securing research data etc.

The Research Advisory Board (RAB) will be formed under the Chairmanship of Dr. S. Y. Kulkarni, Additional Director and by involving experts from industries and R & D organizations. This RAB shall meet twice a year to guide and assess Research activities in the Institution and if necessary more meetings will be arranged.

As a major step towards this BNMIT is happy to announce the Research Funding Scheme 2022 which enables the Researcher of the Institution to avail funding from the Management. Separate notifications in this regard will be sent with all details like eligibility to apply and quantum of funding to avail. A Research Review Committee (RRC) has been formed with the Additional Director, Dean (Administration) and Principal as the Members to assess of evaluate the quality relevance of the proposals and recommend for funding. The core management committee shall approve the proposal for the grant of funding. RRC shall also be responsible for periodical review to ensure the satisfactory progress of the Research proposals selected for funding.

Sub: Inviting Research Project Proposals under "BNMIT Research Funding Scheme-2022

The applications are invited from the teaching faculty members of BNMIT working in all the programs including basic sciences for award of research grants under "BNMIT Research Funding Scheme" for the academic year 2022.

As per the provisions under BNMIT Research Funding Scheme 2022, a maximum of up to Rs. 5.00 Lakh per proposal may be considered for approval depending upon the recommendation of the Research Review Committee.

Conditions for submission of the proposals:

- (i) Any faculty member working in BNMIT college can submit the proposal in the prescribed format with necessary annexure enclosed with this letter
- (ii) The Principal Investigator should be full time employee of the institute. There may be co-investigator(s) (maximum up to 2) from the same program / different program / different organization would be working on the project. However, one co-investigator shall be from the BNMIT.
- (iii) Institution shall constitute the Research Review Committee (RRC) comprising of Head of the Institution, Additional Director, Member Secretary, Externals from Industry / Academicians, Heads of all departments as members, for reviewing and forwarding the best research proposals to Research Advisory Committee [RAC].

The proposals should be preferably submitted in the various disciplines such as (i) Mechanical, Material and related Sciences, (ii) Electrical, Electronics and related sciences (iii) Computer, Information and related Sciences (iv) Artificial Intelligence and Machine Learning (v) Interdisciplinary Sciences (Including Bio-Technology, Nano technology, Bio-Medical) (vi) Applied Sciences (Physics, Chemistry and Mathematics) (vii) Management Sciences (viii) Other Disciplines (Automotive, Aerospace, Defense, Agriculture Science etc.,)
