The Chairperson, Sri. Narayan Rao R. Maanay welcomed all the members of the Governing Body (GB) and requested the members to deliberate on the subjects listed in the agenda.

1. Perusal of action taken report and approval of the proceedings of the previous GB meeting held on 30th August 2024.

The Additional Director and Principal read the proceedings of the previous Governing Body meeting held on 27th March 2024. Chairperson asked whether any comments were received on the proceedings of the previous meeting from the members of the Governing Body.

The Additional Director & Principal replied that a note of observation was received from Sri. Ashok R. Maanay. The observation note stated that he had raised objections regarding the year-on-year budget. He expressed concern that none of his objections were addressed with cogent evidence. However, Principal has replied to the objections raised appropriately.

The Governing Body has perused the note and found that the note did not pertain to any agenda of the meeting held on 30th August 2024. The members were of the opinion that the referred budgets had already been deliberated and hence, there is no necessity to revisit the budget again. Since there are no comments from any other members, GB approved the minutes of the previous meeting held on 30th August 2024 by majority of members.

Resolution: All the proceedings of the Governing Body meeting held on 30th August 2024 were confirmed unanimously as presented.

2. Approval of the list of eligible MBA & M.Tech students for the Award of Degree.

The Additional Director & Principal presented the list of **118** MBA students and **3** M.Tech. students and also the 3 arrear students who will be awarded degree on the Graduation Day which will be held on 15.3.2025. He also presented list of **112** MBA students and **3** M.Tech. students those who got first class with distinction and informed the committee that the performance of students is highly satisfactory. He also mentioned that the absolute grading is adopted as per the guidelines of the University for awarding the degree.

Resolution: The Governing Body approved the list of eligible MBA & M.Tech. students for the Award of Degree and also appreciated that the pass percentage with first class with distinction is greater in number (Annexure-1).

3. Approval of the list of eligible Rank Holders and Gold medalists.

The Additional Director and Principal BNMIT presented the list of eligible **10** Rank Holders and **9** Gold medalists to the committee.

Resolution: The Governing Body appreciated and congratulated the eligible Rank Holders and Gold Medalists (Annexure-2 & 3).

The meeting concluded with the Chairperson thanking all the GB members for their active participation and deliberation.
