Minutes of the Anti-Ragging committee Meeting

The Anti-Ragging committee meeting for the Academic Year 2024-25 was held on 30th January 2025 at 11.00 AM under the Chairmanship of Dr. S.Y Kulkarni Additional Director & Principal, BNMIT. The chairman welcomed the members and proposed the agenda of the meeting.

1. The Chairman introduced the committee members and outlined their roles and responsibilities as per the guidelines of AICTE and UGC.
2. The Chairman requested the police officer to ensure that students do not gather in groups outside the campus or on nearby streets, preventing any disturbances that might lead to complaints from neighbours. He also emphasized that vendors should not sell food items near the campus and should maintain a minimum distance of 100 meters
3. The Chairman emphasized that, due to strict vigilance and constant supervision, no incidents of ragging had been reported on campus. He thanked all the members of the anti-ragging squad for their frequent visits to the hostels, canteen, library, and other areas. Additionally, he urged them to remain vigilant and continue their efforts to maintain a safe and disciplined ragging free environment.
4. The Chairman also emphasized the need to increase the frequency of visits to both the boys' and girls' hostels, as well as the college premises, to ensure that students feel more comfortable and free from any incidents of ragging.
5. Mr. Sadhashiv, Sub-Inspector of Police, BSK 2nd Stage, stated that students can approach the police without any hesitation regarding ragging-related issues. He also assured that regular patrolling would be conducted after college hours to ensure safety and discipline.
6. Dr. Sunitha R, Associate Professor, AIML Department, requested the police department to conduct patrolling after college hours to ensure students can reach home safely and on time.
7. Dr. B. S. Anil Kumar, Convener of the Anti-Ragging Committee, explained the measures implemented by the institute to prevent ragging. The following steps were highlighted
 - i) Posters with anti-ragging slogans have been displayed at prominent locations across the college campus and hostels to raise awareness among students
 - ii) Newly admitted first-year students are required to fill out an online anti-ragging affidavit on the UGC portal, duly signed by both students and parents.

- iii) Information regarding the names and contact numbers of the anti-ragging committee and squad is made available to students through the college website
8. Dr. B. K. Jayanna, Chairman and Dr. Subodh Kumar Panda of the Anti-Ragging Squad, presented the squad's report, which clearly indicated that no incidents of ragging had been reported in the hostels or college campus since 2001.
9. Sri Srinivas Rao, parent of Kruthik Jhadav, a VI-semester student from the Mechanical Engineering Department, appreciated the college's efforts in preventing ragging. He also suggested that a copy of the timetable and their ward's attendance details be regularly sent to parents' mobile numbers.
10. Thanush M. Bharadwaj, a fourth-year student from the Department of Mechanical Engineering, stated that no incidents of ragging have occurred at BNMIT. He also highlighted the cordial relationship between senior and junior students, fostered through regular academic interactions and various technical club activities.
11. Sri Anand B. M., Foreman of the ECE Department and a squad member, interacted with both junior and senior students during laboratory hours and confirmed that no incidents of ragging had been reported on the college campus.
12. The Chairman thanked all committee members for their support in fostering a healthy academic environment and contributing to a ragging-free campus
