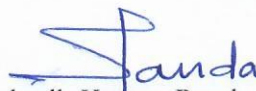
Report on Anti Ragging Squad Visit

7. Students were asked to bring any incidents of ragging to the notice of the principal immediately without any hesitation.

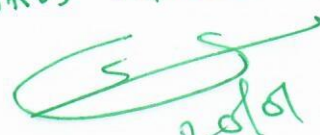
